## NRI Announces the Retirement of Treasury Stock

TOKYO, October 25, 2019 – Nomura Research Institute, Ltd. (NRI) announced that its Board of Directors had passed a resolution in a meeting held today on the retirement of treasury stock in accordance with the provisions of Article 178 of Japan's Companies Act. The details are outlined below.
